

- 5) If you get a response like this, you have to go to court. Ask an attorney or friend who speaks English to help you understand what is happening. You can still apply for asylum, but you might need help from a lawyer or other knowledgeable person. You still must apply for asylum within one year of arriving in the U.S., which might be before your first court date.

CHANGE YOUR ADDRESS WITH IMMIGRATION

It's very important for you to notify US immigration agencies if you move to live in a new place. You must do this within 5 days of moving to a new address. Please ask someone who speaks English to help you.

- 1) If ICE requires you to check in with them and you have a case pending in Immigration Court, scan this with your phone and follow the instructions to let them know about your new address.



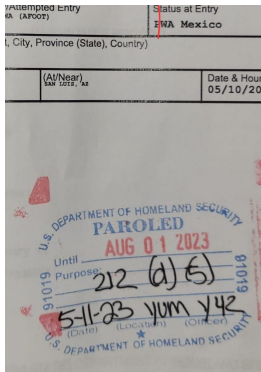
- 2) If ICE requires you to check in with them and you DO NOT have a case pending in Immigration Court, you can notify ICE about your new address at your next check-in.
- 3) If you filed an asylum application with USCIS and you do not have a case pending in Immigration Court, scan this with your phone and follow the instructions to let them know about your new address.



APPLY FOR A WORK PERMIT

1) First, find out if you can apply for a work permit now or have to wait.

a) If you have a document like this, you can apply for a work permit while your parole is valid.



b) If not, you need to file an asylum application first. Then, you have to wait 150 days before you can apply for a work permit. After you apply for asylum, scan this with your phone and enter the date you mailed your application. That will tell you what day you will be able to apply for a work permit. Mark that day in your calendar. Review the work permit application (see step 2) and gather the information you need so you are read to apply on that date.



2) When you are eligible to apply for a work permit, scan this with your phone. Have all of your immigration paperwork with you, and an attorney or friend who speaks English to help you.
